Setting public hearing before consideration of regular annual levy on possible revenue sources for the 2010 budget for November 2, 2009.

BACKGROUND:

As part of the annual budget process, a city such as Spokane that collects a regular property tax levy must hold a public hearing on possible revenue sources for our 2010 current expense budget, including consideration of possible increases in property tax revenues (RCW 84.55.120). This hearing must be held before the meeting the City Council considers the actual levy adoption. Levy adoption itself must occur by Monday November 23 to meet the November 30 deadline to file levy adoptions with the County (RCW 82.54.020), so the proposed pre adoption hearing date is November 2, 2009.
